**Minutes**: The minutes of the September meeting were unanimously approved.

**Treasurer's Report:** The combined balances are 267K. The financials for GAIG are not complete. She also wants to talk about raising the amount of chapter grants for 2026. She brought up the 2027 clinic- do we want Lilo or another clinician? Membership Report: For the year 2025, we have 540 memberships submitted.

The next step will be to agree as a board on the protocol implementation and tracking as well as the reimbursement process. **GAIG Update:** Dianne gave the board her recap. She said it was a wonderful show with huge participation from several regions. We ran a total of 8 rings, of which 5 were used for Championship classes. She hasn't gotten any feedback from USEF but there were no big issues that she knows about. The one area we continue to struggle with is finding an adequate number of volunteers and we should think about a way to incentivize them. Tina reported that we have 70 competitors from this show that will be going on to compete at finals, with not everyone who qualified going. Sheli thanked everyone who helped, supported, and competed.

**GM Representatives for USDF Convention:** The board reviewed the standing rule proposal regarding selection of recipients, attendance expectations and repayment requirements that was circulated before our meeting. Sheli made the motion, seconded by Anne, that VADA reimburse the President, 2 GM voting delegates, and 2 wildcard spots, \$500 each as a stipend for expense reimbursement. We would like to get more members participating. We still have one wildcard spot available. Anyone interested please contact Shelli by October 26<sup>th</sup>.

Year End Award Committee: The date of the banquet is Sunday, February 1<sup>st</sup> at the Greencroft Club. The committee's first meeting was held earlier this week.
